THE AWARDS PROGRAM

Description of the Awards Program: A curated list honoring the most creative people in the experiential world. List is determined by an esteemed group of Jury members ("Judges") who will partake in a nomination and evaluation process to determine this list.

To participate in the Awards Program, depending on your role, you may be required to create an account with and provide your information or the information of other individuals (detailed below) to AwardStage, our business partner for the purpose of the Awards Program. AwardStage is the software platform that we use to collect and hold information on nominees for the Awards, review the nominees and select the final honorees, or administer the Awards Program. The

information you input into the AwardStage platform is subject to and will be governed by the privacy policy and the user terms and conditions of AwardStage.

Upon selection of the Awardees (defined below), we will celebrate your selection at the Awards Program by publishing your selection, professional accomplishments and bases for your selection, and the Awards Program in the media, social media platforms, and through our Business Partners (see <u>How We Use Personal Information</u> and <u>How We Share Information</u>).

C. <u>How this Privacy Notice Applies</u>

This Privacy Notice applies to the information that we may collect from or about you or ask that you provide for your participation in the Awards Program. Your participation in the Awards Program will require you to access AwardStage and provide certain information. If you refuse to do so, we may ask that you not participate in or be a part of the Award Program.

Your participation in the Program will be determined by your role with respect to the Program.

For the Awards Program, you may be selected in the following roles:

- "Administrator(s)" means our personnel who manages and coordinates the Awards Program;
- "Honoree(s)" means any individual nominated by an Entrant for the purpose of the Awards Program and selected by the Judges to receive any award of the Awards Program, and may be subject to our publication of their professional career and selection at the Awards Program;
- "Entrant(s)" means an individual who may not provide information about other individuals considered for the Awards Program, and therefore may not be required to access AwardStage, but whose information may be provided by other participants of the Awards Program, for example, but not limited to, Judges;
- "Judge(s)" means the individuals designated by us to both submit Entrants and be the Jury to consider the submissions of Entrants and decide which Entrants will be selected as Awardees and receive an award of the Awards Program.

D. <u>CHANGES TO THIS PRIVACY NOTICE</u>

The Effective Date at the top of this page indicates when this Privacy Notice was last revised. Unless applicable law prevents or a revision is needed to protect the privacy or security of our Users, we will notify you about any material change that reduces your privacy right in advance so that you have time to review the changes before they are effective. Your participation in the Awards Program after the Effective Date means that you accept the Privacy Notice as revised.

E. <u>PERSONAL INFORMATION THAT WE COLLECT & HOW WE COLLECT</u>

We collect personal information about or from you for the Awards Program primarily through direct communication with you. For example, once you have been nominated as an Entrant for the Awards Program, we may reach out to you via e-mail or phone to inform you of your entrance and participation in the Awards Program. At such time, you will be directed to review this Privacy Notice. If you do not wish to further participate in the Awards Program, you must clearly communicate your wish to withdraw from the Awards Program.

The personal information we collect about or from you may include without limitations: name, address, email, phone number and qualitative input about your specific nominations and evaluations.

F. <u>CHILDREN'S PERSONAL INFORMATION</u>

The Awards Program is not intended for children under 16 years of age, and we will not reach out to you or require you to provide us personal information if you are under the age of 16.

We do not knowingly collect personal information from children under 16 years of age. If you are under the age of 16, you are expressly prohibited from participating in the Awards Program or providing us your personal information including without limitations, name, address, telephone number, email address, or any other information that may be considered "personal information" or "personal data" under applicable law.

G. <u>How We Use Personal Information</u>

Generally, we use the personal information we collect from or about you to more meaningfully administer and manage the Awards Program. More specifically, we use your personal information collected pursuant to this Privacy Notice to:

- Present the awards at the Awards Program
- Respond to your requests and inquiries
- Improve the Awards Program

Market and promote the Awards Program and other related promotional activities

• Evaluate your submissions for deciding in our Awards Program

- Promote the Awards Program
- Publicize the Honores and Judges selected from the Awards Program and Judges

Prevent, detect, and fight illegal or unauthorized activities

- Address suspected or detected unauthorized and illegally activity on or through the Awards Program, such as spam or fraud
- Analyze data related to fraudulent or illegally activities to prevent against reoccurrences and design countermeasures
- Detect security incidents

For legal compliance

- Enforce or exercise our rights
- Audit our event and promotion partners in compliance with applicable law.

H. <u>How We Share Information</u>

With our event and promotion partners

Our event and promotion partners help us to administer, manage, and improve the Awards Program. Our event and promotion partners support technical processing operations, such as data maintenance, event hosting, analytics, securing our data and systems, marketing and promoting our events, such as the Awards Program, and promoting our event participants, as applicable.

For corporate transactions

We may transfer your personal information if we are involved, whether in whole or in part, in a merger, sale, acquisition, divestiture, restructuring, reorganization, dissolution, bankruptcy or other change of ownership or control.

To enforce legal rights

We also share information: (i) if we believe that disclosure would mitigate our liability in an actual or threatened lawsuit; (ii) as necessary to protect our legal rights and legal rights of our Users or other interested parties; (iii) to enforce our agreements with you; and (iv) to investigate, prevent, or take other action regarding illegal activity, suspected fraud or other wrongdoing.

With your consent or at your request

We may ask for your consent to share your personal information with third parties. When we do, we will make clear why we want to share your personal information.

I. OUR USE OF COOKIES & TRACKING TOOLS

For purposes of the information we are collecting and using for this Awards Program, we do not use cookies and other data tracking technology to collect and use personal information about you, but AwardsStage will use cookies in order to operate the platform and assist in the performance of the Awards Program. As in <u>Personal Information that We Collect & How We Collect</u>, we collect personal information from you through direct communication—e-mail, snail mail, text or phone call or through your provision of information directly to us or the AwardsStage platform.

J. <u>How We Protect & Retain Information</u>

We use physical, technical, and organizational measures designed to protect your personal information against unauthorized access, theft, and loss. We restrict access to your personal information to those employees who need access to manage and administer the Awards Program or perform their job functions. We have procedures to manage personal data breaches and will notify you and any applicable regulator when we are required to do so. You understand and agree that we may deliver electronic notifications about breaches of security to the email address that you provided to us.

Although we take precautions intended to help protect the personal information that we process, no system or electronic data transmission is completely secure.
